1. Introduction

This document ("Privacy Commitment") outlines how Bitcoin Minetri ("Our Team", "We", "Our" or "Us") manage, utilize, and safeguard Personal Details of the users who interact with or use our services on our platform including, but not restricted to, <https://BitcoinMinetri.com> (jointly, the "Platform"). You agree that this Privacy Commitment does not apply to any third-party platforms, systems, or applications, even if they can be displayed, reached or seen to interact with our website.

By using our services available via our platform, <https://BitcoinMinetri.com>, you willingly consent to the management, utilization, and sharing of Personal Details as elaborated below.

2. Acceptance of Terms

By accessing or using the [Bitcoinminetri.com](https://BitcoinMinetri.com), you acknowledge that you have read, understood, and agree to abide by this Privacy Policy. The Privacy Policy may be changed at any later time which can be checked against the "Last Updated" date. By continuing to use the website (<https://bitcoinminetri.com>) after the updates, you inherently agree to the modifications of this Privacy Policy.

3. Definitions

The headings used in this document are purely for ease and should not influence its interpretation. Definitions in this glossary will hold their meaning irrespective of their singular or plural usage.

Within the scope of this Privacy Policy:

Profile: Represents a distinct profile made for your interaction with our offerings or specific aspects of our offerings.

"Our Team", "We", "Us", or "Ours": Refers to the Bitcoin Minetri team

Web Cookies: Small data packets placed on your computing device by a website that capture details of your online activities on that particular site.

Equipment: Any equipment that can interface with our services such as a PC, a smartphone, or a digital pad.

Personal Details: Information pertaining to an individual who is either identified or can be identifiable.

Service Providers: Denotes any individual or organization who handles data on our behalf. This can include third-party entities or people who we employ to support our services, to deliver the services on our behalf, to provide related services or to aid us in understanding how our services are utilized.

Engagement Data: Data that is gathered automatically from the use of our services or the infrastructure of our services itself (like the duration of a webpage interaction).

Platform: Refers to BitcoinMinetri.com, accessible from <https://BitcoinMinetri.com>

User: Represents the individual engaging with our services or the corporate body or other legal entities for whom such an individual is engaging with the services.

4. Information We Collect

a. **Financial Data:** In the course of using our services, you may provide financial information, such as cryptocurrency wallet addresses, bank account information, and transaction history;

b. **Technical Data:** We may collect technical information about your device, including IP address, browser type, operating system, and usage data.

c. **Cookies Data:** We may use cookies and similar technologies to collect technical and marketing information to enhance and personalize your user experience. For more information about this, please refer to our Cookies Policy;

d. **Engagement Data:** This can encompass, but is not confined to, data such as Your Equipment's Internet Address (IP address), browser specifics, browser version, pages of our offerings that you interact with, timestamps of your visits, the duration spent on those pages, and other diagnostic data. For those accessing our services via a mobile device, data like device type, unique device ID, IP address, mobile OS, browser type, and other such data may be gathered;

e. **Communication Data:** We may collect information related to your communication with us, including customer support inquiries, feedback, and chat messages;

f. **Personal Data:** In certain circumstances during your engagement with our services, we might need to collect some personal details about you.

5. Gathering and Employing Your Personal Details

When you get in contact with us, we might request you to share specific identifiable details that can be employed to recognize you. Identifiable details can be inclusive of: Full Name, Email Address and Engagement Data which is gathered automatically during the use of the services.

Unless specified above, these types of information are not collected by default for all users, instead we employ these in the event of you trying to contact us in regards to requesting support for any arising situations with your wallet, purchase, post-presale claiming of tokens or staking.

6. How We Use Your Information

We may retain the details gathered in alignment with this Privacy Commitment for the duration of your engagement with our services or as required to provide our services, address disputes, establish legal defenses, conduct audits, pursue legitimate business objectives, and adhere to legal mandates. The purposes for which we collect and retain data include but are not limited to:

a. **Providing Services:** To provide, maintain, and improve our cryptocurrency mining and trading services;

b. **Communication:** To respond to your inquiries, provide customer support, and send important updates and notifications related to our services;

c. **Analytics:** To analyze and monitor user behavior, preferences, and trends to enhance our website and services via platforms such GA (Google Analytics), and AWS (Amazon Web Services);

d. **Legal Compliance:** To comply with applicable laws, regulations, and legal processes, including anti-money laundering (AML);

e. **User Authentication:** To verify your identity and protect against fraud, unauthorized access, and security breaches. This only applies to certain circumstances mentioned above and only if you get in contact with us first.

7. Transfer of Your Personal Information

Your information, including Personal Information, is processed at the Bitcoin Minetri's operating offices and in any other places where the parties involved in the processing are located. We are not going to sell your personal information to third-parties. However, in special circumstances, this information might be transferred outside of Bitcoin Minetri servers and or outside of the jurisdiction Bitcoin Minetri is registered in as outlined in the next section. In the event we are transferring your data to a third party, we will employ security measures to ensure the confidentiality of your data. Your consent to this Privacy Policy followed by Your submission of such information represents your agreement to the aforementioned.

8. Disclosure of Your Personal Information

Your personal information might be shared with or transferred to third parties for the purposes below.

a. **Business Transactions:** If Bitcoin Minetri is involved in a merger, acquisition or asset sale, your Personal Information may be transferred to the company involved in these processes;

b. **Law Enforcement:** Under certain circumstances, Bitcoin Minetri may be required to disclose your Personal Information if required to do so by codified law or in response to valid requests by public authorities (e.g. a court or a government agency);

c. **Other Legal Requirements:** Bitcoin Minetri may disclose your Personal Information in the good faith belief that such action is necessary to: comply with a legal obligation, protect and defend the rights or property of the Company, prevent or investigate possible wrongdoing in connection with the Service, protect the personal safety of Users of the Service or the public, protect itself against legal liability.

9. Data Security

We employ industry-standard security measures to protect your personal information from unauthorized access, disclosure, alteration, or destruction. However, no data transmission over the internet or storage method is completely secure, so we cannot guarantee absolute security.

10. Your Choices

You have the right to access, update, or delete your personal information held by us. You may also choose to limit the information you provide to us, but this may affect your ability to use certain features of our services.
