1. Introduction

The following Terms of Use govern your access to and use of the Bitcoin Minetrix token (\$BTCMTX), the Bitcoin Minetrix website https://bitcoinminetrix.com and any related services provided by Bitcoin Minetrix. By accessing, using the website (https:// bitcoinminetrix.com) and/or purchasing and using \$BTCMTX token, you agree to comply with and be bound by these terms. If you do not agree with these terms, you must refrain from accessing or using https://bitcoinminetrix.com.

These terms of use along with the Privacy Policy and Cookies Policy also available on the website constitute your legal agreement between you and Bitcoin Minetrix. "Bitcoin Minetrix" refers to the cryptocurrency project developed with the objective as defined by its creators.

"Bitcoin Minetrix" can also refer to the company, when that is the case, the word "company" would be included to avoid confusion with the same-name project specified above.

"\$BTCMTX" refers to the digital cryptocurrency token associated with the Bitcoin Minetrix project.

"Users" or "You" refers to any individual or entity that purchases, uses, or interacts with either the website https:// bitcoinminetrix.com or the token \$BTCMTX.

4. Project Description and Company Identity

Bitcoin Minetrix is the first stake-to-mine cryptocurrency project which gives buyers the opportunity to earn credits for staked tokens that can later be exchanged for an amount of mining time. Its operations and revolutionary utility are supported by \$BTCMTX which is an ERC-20 token developed on the Ethereum Blockchain.

The project is developed by Cloud Tech X23 Limited which is registered in Marshall Islands and has offices based in Trust Company Complex, Ajeltake Road, Ajeltake Island, Majuro, Marshall Islands MH96960. The location and country of the Bitcoin Minetrix company does not represent the location of the mining facility which does not form part of the company and will be revealed later at our sole discretion. Therefore these two should not be considered or expected to be the same entity.

5. Eligibility

You must be at least 18 years old to use our platform. By using https://bitcoinminetrix.com, you confirm that you are of legal age in your jurisdiction.

We are not intending to market our services to anyone underage. If any minor engages with https://bitcoinminetrix.com and/or buys \$BTCMTX token, it is considered they do so with the support and consent of their parent or guardian and therefore, we are not made to be responsible for their activities.

6. Prohibited Activities

While using Bitcoinminetrix.com, you agree not to:

a. Engage in illegal activities, including money laundering, fraud, or any other criminal behavior.

b. Disrupt the platform's functionality, attempt to hack, or gain unauthorized access to our systems.
